The City Council Government Operations Committee, Chaired by Hon. Mary Pinkett, will meet to discuss the proposed merger of the Department of Mental Health with the Department of Health on May 28, 1998. The meeting is scheduled to take place at 10 a.m. in the City Council chambers. The proposed merger is second on the agenda following a discussion of the Mayor's preliminary management report. Discussion of the merger is expected to begin around 11 a.m. Coalition members are encouraged to attend.

More detail on the City Budget

The details of Mayor Giuliani's proposed FY 1999 budget for the City of New York are becoming more clear as time progresses. The total budget of the Mental hygiene section of the proposed merged Department of Public Health is \$411.7 million. This represents an increase of 13.6% over the 1998 adopted budget for DMH of \$362.3 million which was itself an increase of 7.6% over the 1997 adopted budget of \$336.9 million. This \$411.7 million breaks up into five distinct units of appropriation which enable us to track the mental health dollars with a fair degree of accuracy. Mental Health services total \$145.3 million. The Early Intervention Program is budgeted for \$159 million. Mental Retardation services are funded at \$43.2 million. Alcoholism and Substance Abuse services are funded at \$44.8 million, and administrative services account for the remaining \$19.3 million.
