Final PAR application issued

The Coalition has received from OMH its final PAR Application Form, which replaces the draft application form issued earlier. As noted in earlier issues of Briefs, OMH's new PAR ("Prior Approval Review for Quality and Appropriateness") regulations went into effect on March 5, 1999. This Application Form is to be used for the new approval process. Providers have joint meeting with OASAS and OMH

On March 24th over 100 mental health providers from all over New York State met in Albany to discuss the future delivery system for people with co-occurring psychiatric and addictive disorders. OMH Commissioner James Stone and his staff were joined by OASAS Commissioner Jean Sommers Miller and her staff to discuss the proposed New York Plan for treating people with co-occurring disorders and the provider role in shaping the future system.

The morning was devoted to a presentation of the plan, and the afternoon was spent with three roundtable discussions with members of the government agencies and provider representatives. Panel topics included treatment models, licensing and regulatory issues and the provider role in developing the initiative. Attendees were asked to fill out interest inventories indicating the areas in which they would like to help the State in its planning.

We feel that the day was a success, and hope that it will represent the beginning of an increased provider role in shaping the future of the care delivery system for people with co-occurring disorders. ■

Funding for antipsychotic Rx

The Governor's proposed FY2000 budget for the Office of Mental Health includes an increase of \$11.6 million for OTPS adult services. This money is earmarked to cover the costs of atypical antipsychotic drugs for people in inpatient State-run settings. OMH is already paying for these newer, more expensive drugs and the allocation will cover losses and allow them to prescribe the drugs more freely going forward.

In working to determine if a similar initiative is underway for people in community-based settings Coalition staff discovered that, in fact, Medicaid

will cover any antipsychotic drug a community-based provider prescribes, including atypicals. With the exception of clozapine, which has potentially fatal side effects, clients are not required to try the older medications before the atypicals can be prescribed.

We applaud the Governor's recognition that advances in antipsychotic medications require additional funding and hope that the administration will recognize that the costs of providing mental health treatment increase with inflation as well as science.

NYS budget will be late

The legislature has gone home for the holidays without passing a budget. For the 15th consecutive year, the New York State budget will be late. The legislature is set to return on the 12th of April and at that point they will likely wish to move ahead quickly as legislators stopped getting paid on April 1st. The delay causes some problems, but it also gives us an opportunity to make our case for trended rate increases.

The Coalition has produced 30,000 postcards for legislators and the Governor. They are in the mail to other provider organizations and agency directors. Keep an eye out for them and for Action Alerts.

DMH announces education grant

The Department of Mental Health announced on March 25th that workers employed in mental hygiene agencies currently under contract with the Department are eligible for the Mental Hygiene Training Program leading to a Master's Degree in Social Work from the Hunter College School of Social Work. Successful applicants will receive a grant from the Department for the full cost of tuition for Hunter's One-Year Residency Program. Applicants must have a bachelor's degree and a minimum of two years experience in mental hygiene and social work related tasks.

The goal of the program is to increase the number of culturally competent professionals available to work with the diverse populations served by community-based agencies in the City.
